CGU Insurance is committed to protecting the personal information it holds and uses about you.

Collection

We will only collect information that is necessary for us to provide you with our products and services.

We collect your personal information in various ways, such as via application or claim forms, over the telephone and via the internet if you transact with us online. Some examples of personal information we collect include your name, address, date of birth, gender, health information, employment details, details of your previous insurance and details of your personal assets.

Wherever possible, we will collect information directly from you.

Where we collect information about you from a third party, we will advise you.

If you choose not to provide us with the requested information, we may not be able to process your request.

Use and disclosure

We will use your personal information in accordance with the National Privacy Principles, such as the purpose for which it is collected, to provide you with products and services, and (subject to your consent), for marketing purposes.

There may be occasions where we may need to disclose your personal information to third parties such as other insurers, health service providers, investigators and repairers.

We will not disclose information about you to a company which is not a related entity unless the disclosure is required or authorised by law, or you have consented to the disclosure.

Quality and security

We will take reasonable steps to ensure that the personal information we collect, use and disclose is accurate, complete and up to date. We will take all reasonable steps to protect the personal information we hold about you from unauthorised access, use and disclosure. We will destroy your information when it is no longer needed.

Access

If you wish to access the personal information we hold about you, contact or visit one of our branches. For more complex requests, you may need to complete an access request form.
